Description of the error in the LIAB variable "Status of establishment number" (betr_st) in certain LIAB datasets

The variable "Status of establishment number" (betr_st) is a generated variable that classifies employment records as follows:

1	Establishment of IAB Establishment Panel, in this LIAB version on reference date (surveyed within the time period covered by the employment record)
2	Establishment of IAB Establishment Panel, in this LIAB version, not on reference date (not surveyed within the time period covered by the employment record)
3	Establishment of IAB Establishment Panel, not in this LIAB version
4	No establishment of IAB Establishment Panel

In certain LIAB versions up to 25 percent of the employment records were misclassified as 2 instead of 1 and as 1 instead of 3. The following table shows in which LIAB datasets the variable is incorrect and in which it is correct:

How did the error occur?

Two programming errors were made: Error 1 (value 2 instead of 1) is due to a merge without a key variable. Error 2 (value 1 instead of 3) reflects that all employment records that could be merged to a surveyed IAB Establishment Panel were classified as 1. Correct is only to classify records that merged to one of the firms <u>selected for the specific LIAB version</u> as 1, all other merges belong to status 3.

How to prevent such errors in the future?

We continuously try to improve the quality of our data and to reduce the risk of errors. One important step was taken in 2010 when we wrote down and committed ourselves to a list of measures to assure the quality of the data and documentation we produce. We believe that, by this means, the risk of data errors like the one described in this paper has been further reduced. An unavoidable minimum risk will remain.
